In the reference 1st cited, Government have issued instructions for collection of comprehensive data relating to Government employees, pensioners and their family members/dependents in the prescribed proforma through the IFMIS-HR Module on or before 31.05.2026.

2. In the reference 2nd cited, the State President, Telangana State Government Retired Employees Association, Hyderabad, has represented that pensioners/family pensioners, particularly senior citizens, are facing difficulty in approaching the concerned Treasury Offices in person for submission of details.

3. After careful examination of the matter, Government have decided to utilise the existing data of Pensioners/ Family Pensioners and their family members and dependents, available with the Rajiv Aarogyasri Health Care Trust (EHS). In cases where any corrections or modifications are required, the Government Pensioners/Family Pensioners may approach the concerned Pension Payment Officer or Treasury Officer, without any time limit, for carrying out necessary corrections.

4. The Director of Treasuries and Accounts, Telangana, Hyderabad, shall take necessary action accordingly.
